The Clerk was requested to make enquiries with North Lincs regarding the Sports Ground and the use of this for a Car Boot etc.

A grant will be required for the path -3 quotes to be sought for the footpath for application when there is a bank account

b) PC donation of S137 from 1st April; the auditor from 2022-23 internal audit clarifies the council running of the Millennium Green and funding – the council can legally donate funds providing they have funds to donate and the council agree to the funds being donated. If a bank account is set up then the Parish Council can not pay anything for the Millennium Green Trust directly eg Grass Cutting.

The Clerk recommended to the MGT Committee that an informal discussion with the contractor at this stage *before* there were any decisions made would be advisable. The Clerk will meet with the contractor for an informal, courtesy discussion explaining the situation and discussing the possible resolutions.

MGT2403/11 **Drainage issues**

The dyke is contaminated with contaminated waste which is spilling over from neighbouring land.

The Clerk will contact Environmental Health at NLC requesting them to contact the owner to be cleared from the owner's side, pointing out that the blockage is causing the dyke to overflow which is possibly causing the flooding on the roadway.

The Working Group will remove the large fallen trees over the dyke.

Specialists have been instructed to look at drainage; MGT are awaiting a response from drainage board
